The Story

Describe the students and community and how the LEA serves them.

Pacific Union serves 388 students in grades Tk-8th grade. The unduplicated population is 88%. English learners make up 58.8% of the population. 87.4% of the students are socioeconomically disadvantaged. Pacific Union Elementary School District is a 22 square mile rural district. Pacific Union provides a safe and secure environment for students. The student to device ratio is 1:1 in grades TK-8. Students receive additional educational experience outside the classroom through each two grade level field trips each year. Pacific Union provides opportunities for parent/guardian/community engagement through school functions, i.e., Back to School Night, Literacy Night, Parent-Teacher Conferences, Craft-Extravaganza, Halloween Parade, May Fiesta Celebration, Open House, Oral Interpretation, etc. Pacific Union is a TK-8 school and the following metrics do not apply: A-G, CTE, AP, EAP, High School Dropout, and Graduation Rates.

LCAP Highlights

Key features of this year's LCAP include: increased campus safety and additional CPR training (Goal 2, Action 2 and 6); increased safe and welcoming P.E./sports spaces (Goal 2, Action 2); increased psychological services to 3 days per week (Goal 2, Action 3); additional support for subgroups with Common Core (Goal 1, Actions 1, 3, and 4); increased involvement with parent/guardians concerning grades, attendance, and behavior (Goal 2, Actions 3, 4, and 5); hiring a full-time music teacher to expand the music program (Goal 2, Action 7); additional experience for students outside

the classroom through field trips (Goal 1, Action 5); full implementation of the Time to Teach behavior intervention program (Goal 2, Action 5), and increased Professional Development for teachers (Goal 1, Action 6).

Greatest Progress

Pacific Union's students have increased performance on state assessments. The percentage of students meeting or exceeding standard has increased by 0.89% in English Language Arts. Additionally the percent of English Learners meeting or exceeding standard at Pacific Union in English Language Arts was higher than the California average for English Learners in all grade levels except 3rd and 6th. The same is true for Math in all grades except 3rd. 6.3% of English Language Learners met reclassification criteria. Students reading at or above grade level increased 7%. Although the dashboard shows red for Suspension Rate, Pacific Union decreased Suspension Rate 0.64%. With a Status of 2.96% and change of 0.64%, the updated color will be Green. ADA was maintained at 95%. 100% of students are provided sufficient materials. The LCFF funds provided to Pacific Union to increase and improve services have given Pacific Union's students the opportunities and support necessary to continue to make progress in these areas. Pacific Union will build upon its success by providing additional support for the unduplicated population through summer school, after-school tutoring, and intervention programs; field trips; increased technology; and increased parent involvement.

Greatest Needs

Suspension Rate is Red, however it is outdated. It will be green in Fall 2018. ELA and Math are Orange. Pacific Union will continue professional development for teachers/aides in the areas of English Language Arts and Mathematics as well as add additional classroom aides for intervention.

Priority 7: Course Access addresses the extent to which pupils have access to and are enrolled in:

- A. S broad course of study including courses described under *EC* sections 51210 and 51220(a)-(i), as applicable;
- B. Programs and services developed and provided to unduplicated pupils; and
- C. Programs and services developed and provided to individuals with exceptional needs.

Priority 8: Pupil Outcomes addresses pupil outcomes, if available, for courses described under *EC* sections 51210 and 51220(a)-(i), as applicable.

Priority 9: Coordination of Instruction of Expelled Pupils (COE Only) addresses how the county superintendent of schools will coordinate instruction of expelled pupils.

Priority 10. Coordination of Services for Foster Youth (COE Only) addresses how the county superintendent of schools will coordinate services for foster children, including:

- A. Working with the county child welfare agency to minimize changes in school placement
- B. Providing education-related information to the county child welfare agency to assist in the delivery of services to foster children, including educational status and progress information that is required to be included in court reports;

 - (1) The number of cohort members who dropout by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
 - (2) The total number of cohort members.
 - (3) Divide (1) by (2).
- (d) "High school graduation rate" shall be calculated as follows:
 - (1) The number of cohort members who earned a regular high school diploma [or earned an adult education high school diploma or passed the California High School Proficiency Exam] by the end of year 4 in the cohort where "cohort" is defined as the number of first-time grade 9 pupils in year 1 (starting cohort) plus pupils who transfer in, minus pupils who transfer out, emigrate, or die during school years 1, 2, 3, and 4.
 - (2) The total number of cohort members.
 - (3) Divide (1) by (2).
- (e) "Suspension rate" shall be calculated as follows:
 - (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was suspended during the academic year (July 1 June 30).
 - (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
 - (3) Divide (1) by (2).
- (f) "Expulsion rate" shall be calculated as follows:

- (1) The unduplicated count of pupils involved in one or more incidents for which the pupil was expelled during the academic year (July 1 June 30).
- (2) The unduplicated count of pupils with a primary, secondary, or short-term enrollment during the academic year (July 1 June 30).
- (3) Divide (1) by (2).

- 5) What progress has been achieved toward the goal and expected measurable outcome(s)? How effective were the actions and services in making progress toward the goal? What changes to goals, actions, services, and expenditures are being made in the LCAP as a result of the review of progress and assessment of the effectiveness of the actions and services?
